

2021 Ontario energy and property tax credit (OEPTC) - Calculation sheet for single seniors who have the sole care of at least one child

Use this calculation if you were **64 years of age or older** and single on December 31, 2020, and you have the sole care of at least one child who is under the age of 18 on the first day of the payment month.

You may have to use a different calculation sheet for a particular month if the care of any of your children changes.

If your annual OEPTC amount plus, if applicable, your annual Ontario sales tax credit and Northern Ontario energy credit is:

- \$2.00 or less, no payment will be issued.
- from \$2.01 to \$10.00, you will receive one payment of \$10.00.
- \$360.00 or less, you will receive it in one payment instead of monthly.

The first monthly 2021 Ontario trillium benefit payment, which includes any OEPTC entitlement, will be issued on July 9, 2021.

However, if you made a choice on your 2020 return to wait to receive your 2021 OTB entitlement, it will be issued on June 10, 2022.
